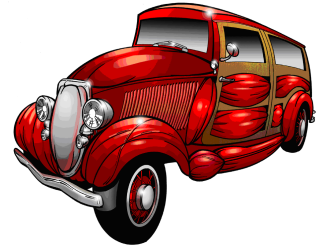




Que and Cruz 2013

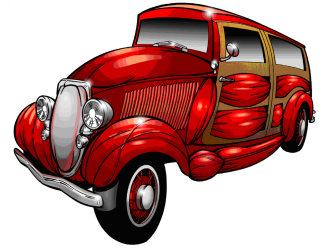
