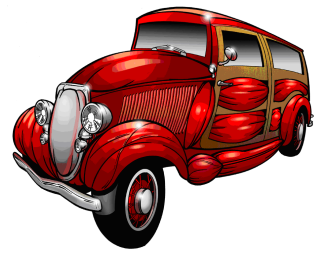




# **Que and Cruz 2018**

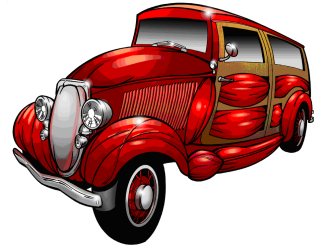
